Unsafe pool facility	Swimmers, Coaching staff, officials, spectators	Team Manager (or allotted representative/s) conducts an "on day" risk assessment of the facility (including spectator gallery, changing rooms, etc.) at least ½ hour before event start time.	Medium	Any concerns are immediately reported to facility duty manager.	Team Manager	None
Gala is not manned effectively	All	An agreed list of required posts/duties is in place.	Medium	Responsible persons are allotted to specific duties, e.g. manning spectator entrances, gala officials, etc.	Swimming Committee	None
Pool facility is not ready for gala start time	All	An allotted club official checks facility at least ½ hour before event start time.	Medium	Any concerns are reported to facility duty manager.	Allotted person	None
Changing for gala	Swimmers	Male and female chaperones supervise swimmers in changing rooms.	Low	Chaperones are vigilant for any safe guarding issues. Personal belongings to be taken to poolside.	Chaperones	None

Injury from pool facility, e.g. broken tiles , pool furniture, etc.	Swimmers and coaching staff	An “eyeball” of pool facility is conducted prior to event start.	Medium	Any hazard identified to be reported to facility Duty Manager.	Team Manager	None
Injury from swimmers’ equipment, e.g. trips	Swimmers, coaching staff, facility staff, public	All swimmers are advised of need to leave equipment bags so that access to and around poolside is not impeded.	High	Swimmers to deposit kit bags such that access to and around poolside is not blocked.	Team Manager	None
Non compliance with NOP at pool facility	All	Compliance with local NOP is ensured. Visiting teams are advised of facility NOP and any local rules.	Medium	Ensure awareness of the NOP and general rules of the facility. Pool staff are fully supported in enforcing the safe running of the event.	Team Manager	None
