This document highlights how Wandsworth SC intends to reasonably protect any athletes, parents, guardians, workforce and centre staff from the risk of Covid-19 at Putney Leisure Centre. The protocols listed within this document will be reviewed regularly and changed accordingly if measures or guidance changes.

In addition to the Risk Assessment details provided below the following

1. Requested Hours

- a. Tuesday, Wednesday and Friday hours of 6pm to 9pm
- b. Weekend hours of 7am-11am both days

2. COVID-19 Marshals

We will provide on-site COVID-19 Marshals (as recommended by Swim England), to manage, monitor, and ensure that the pool entrance, use, and exit protocols are followed.

3. Pool Site 'Isolation'

Our recommendation (using Swim England guidelines) is that the pool is 'isolated' from the rest of the leisure centre. This would include the entrance stairwell and changing rooms. There should be no mixing of squad and public sessions in the pool.

4. Pool Capacity

We will follow the Swim England guidelines of 6 per single width lane in a 25m pool. We will therefore not exceed 8 per single width lane at Putney Leisure Centre. The capacity of the pool is therefore 48 athletes.
