SWIMMING SECRETARY REPORT – NOVEMBER 2020

The focus of this report will principally be the 2021 Oxfordshire & North Buckinghamshire Counties ASA Championships.

As you may have seen Swim England, before the recent lockdown, released a five-point roadmap to swimming competitions, part of which was the launch of Level X racing, which for the time being has been suspended due to the latest government lockdown restrictions. Because of the level of uncertainty surrounding the commencement of competitive swimming, stages 4 and 5 of the roadmap, (which refers to the reinstatement of licences meets), does not detail any timelines. Meet licence levels one and two fall under stage five of the roadmap and is incumbent on stage four being delivered successfully.

The expectation was that we would not move to stage four before January 2021 at the earliest; it is therefore likely due to the current situation and the government's re-evaluation of the tier system, that the move to the reinstatement of licence meets be further delayed.

The Swim England leadership have decided to suspend the normal County Championships window, and are proposing an alternative Championship window that will run from; late May to 18th July 2021. With a second racing opportunity to Counties later in the year so that older swimmers sitting examinations are provided with the opportunity to participate in a county competition at an appropriate time. The current plan is to run Regional Championships within their usual window. These plans are, however, being kept under review.

We are keen for the 2021 County Championships go ahead, however, until further guidance issued by Swim England and timelines and competition windows firmed up, it would appear ill advised to lay firm plans as change is inevitable.

O&NB County Artistic (Synchronised) Swimming Report

November 2020

Since September Witney Synchro has been able to continue some water sessions at the Windrush Leisure Centre and Land sessions at the Langdale Hall along with a Zoom exercise class each week.

They also managed 5 weeks of pool sessions at Oxford High School – unfortunately this then stopped as they were then unable to continue to provide a NLPQ lifeguard. Then one of the regular facilities that were yet to open reported that they would not be opening to bookings for another 5-6 months at least.

This does therefore mean that the Oxford City and East of the county-based members no longer have any local sessions and for some this has meant a further interruption in their participation. This has also meant difficulties in taking in any new members.

Following the start of the second lockdown Witney Synchro have set up Zoom Land exercise sessions to cover each water session and several athletes and coaches are also attending Webinars from GB Synchro sources through Swim England . Our Level 1 Coach candidate passed her theory section but has been unable to complete the qualification by attending either of the practical section sessions in Rugby and Reading.

Milton Keynes are due to start up again with 1 hour per week in December when this lock down is over but are unsure of what their numbers will be after the long break.

There is still mention of GB trials taking place in January, but no further information has been received by Clubs concerning these or of the online coaches' conference which was due to take place in December.

Fingers crossed we can all get back in the pool come December 3rd!

Level X

Timekeepers have done the T/K for £5 first and then continue onto the full J1 course, will have this course fee discounted.

Under NO circumstances should "practical" training be carried out on poolside, during Level X events. Nor any other time, unless an approved, by British Swimming (BS) & SE.

Licensing

All renewals of Officials' Licences have been put on hold for the time being and we are awaiting further information on the procedures once this are re-started. It shouldn't cause any issues as there are no galas and Officials with lapse licences can still work at a Level X Gala as the only requirement is to be qualified (once you pass your assessment you become and remain qualified)

Please could we remind all officials that any queries should not be made directly to Swim England or British Swimming but should first go through either myself or Felicity as ONB representatives or George Adamson as South East representative.

Oxfordshire & North Buckinghamshire Meeting - November 2020

COVID 19 – Update – This is what the new restrictions mean for all aquatic activity.

- School swimming School swimming lessons as part of the national curriculum can take place in a schoolowned pool or usual venue if the operator is open.
- Universities and boarding schools Swim England understands boarding schools may use their own facilities
 for their pupils as now, but may not invite those outside the boarding school into the facilities. This will be
 confirmed later today. It is understood university pools may only open for elite return-to-training purposes.
- Private and public pools All pools must close unless they are able to stay open to facilitate school swimming
 lessons only. Private pools can only be used by the owner's immediate family or support bubble and must not
 be hired out.
- Club activity Sadly, club activity at pools must not take place at pools during the lockdown. Virtual home activity sessions can be organised by clubs to help keep members active.
- Learn to swim (excluding school swimming) All learn to swim sessions, including baby swimming, are on hold during the lockdown. No 1-2-1 lessons that are held in private or endless pools can take place.
- Elite training Elite training can continue in designated facilities under the original Return to Training Guidance. Only those swimmers who were named on the original list during the first lockdown are eligible. Swim England will be working with British Swimming to try to keep these swimmers in the water if possible.

Swim Mark

At the September SwimMark panel the following clubs maintained their accreditation Banbury, Buckingham Swans, Kidlington and Gosford and Wantage White Horse.

The following clubs are currently submitting evidence for the November SwimMark Panel; Bicester Bluefins, Bletchley and District, City of Milton Keynes, Didcot Barramundi, Newport Pagnell and Witney and District,

For both SwimMark and Stronger Affiliation purposes, Swim England have developed a PDF download for club personnel records through the Swim England Online Membership system. This replaces all other evidence to be provided for element 13. Clubs are encouraged to update their records on that system in preparation.

Stronger Affiliation

Clubs are now able to upload their evidence onto the portal. As part of this process we are encouraging clubs to update their constitutions now and start to upload onto the Portal.
