During the last meeting I was tasked with looking at the creditors account to see what clubs had outstanding. The following has been identified:

  - a. Thame Jan 2018 request for £294.87
- 2. Funding Training coaches
  - a. Didcot Sep 2013 Irena assessment outstanding £308.56
- 3. Officials Room hire
  - a. Several entries in the creditors account for £654.50, room hire but no invoices to cross match, dates range from 2015 to 2017.

This will give a new total of £1565.40. I have been unable to match £523.46 to funding requests, but I think these are probably historical mistakes (Payments not transferred into the creditors account). #### May 2021

#### **Since the March report:**

Witney Synchro have passed their revalidation for Swim Mark.

Witney and District Synchronised Swimming Club has now officially been renamed as 'Oxford and Witney Artistic Swimming Club' – but still keep the code of WDSS.

WDSS were able to return to the pool on April 12<sup>th</sup> and to the same sessions from December. They have been able to welcome a small number of new starters and have a short waiting list for over 16's.

Artistic Swimming (Swim England) has put out guidelines for return to training, competition and grades. There will be a series of virtual events from May to December including Level X competitions and National Championships. A new format of grades has been devised for virtual use until later in the year when it may be possible to return to face- to- face grade testing especially within regions.

#### Masters Report May 2021

Since the last meeting a survey has been sent out to all masters swimmers within the county to find out the level of interest in putting on a county competition for Masters. At the time of writing these results are being collated to be analysed. I will provide an overview at the next meeting of the findings from this.

I have attended the meetings put on by both Swim England and South East Region about return to competition. After careful consideration and consultation with the South Bucks representative we have decided that it is not sensible to look to host a masters county competition this year and I will look to the results of the survey to decide the most appropriate way forward for next year.

There was an informative virtual meeting on Thursday 6<sup>th</sup> May hosted by Jeroen Peters for masters regarding the role of the Masters Working Group and the opportunities for masters to become involved in the shaping of the future path of masters swimming within England. The link for this meeting was distributed to all clubs and hopefully all interested individuals were able to attend, however a recording of that meeting will shortly be made available. When I am made aware of the link I will distribute it to all clubs.

## The Oxfordshire and North Buckinghamshire (ONB) Amateur Swimming Association

#### May 2021 Officials' Report

We have received some further information regarding training of officials and return to competition although some of it is still 'tentative'.

#### **Training**

Extension of 'end dates' for completion of both old and new style J1 training will be published when full competition recommences. Likely extensions of time once we recommence could be, old style for at least 3 months and new for 11 months. However, no trainee or qualified official will be penalised for time lost during any pandemic restrictions.

#### **Competitions**

Covid restrictions for officials' requirements, still apply for Level X competitions and those details have also already been circulated. These will be strictly enforced.

There will be some changes to the officials' requirements and training and assessments when meets restart. We are still waiting the full details of the restrictions, but it is anticipated that these will be in force until at least Sept 2021.

#### License renewal

Any official that has an expired license, post March 2020 should not worry about its renewal until announcements are made on competition restart, we expect that these will include an automatic extension time.

#### **South East Survey**

South East region has carried out an Officials' Survey and have shared the results. This shows an expected loss of officials and they state, "Even before the pandemic, clubs struggled to get sufficient officials for meets; the loss of 15-20% of our officials will exacerbate that problem as many clubs want to run meets to rebuild finances".

I have broken down the figures for ONB as best as I can, we also had 14 people who actively asked to be removed from ONB Officials' Mailing List and several email bounce backs that could suggest these people may also not be active officials.

These numbers appear to show a worrying drop in number of officials and suggests that some clubs may struggle to find enough officials to successfully run licenced meets.

#### **County Team Coach Report – May 2021**

#### **Update on County Development Camp for 2021**

The idea was to run a full weekend camp (Saturday/Sunday).

- Saturday for the missed swimmers from last year.
- Run as normal as multiple one day events.
- Possibly increase numbers based on Level X swims?

Then this year's swimmers (on Sunday) ask clubs to nominate 2 x girls and 2 x boys in the relevant age group. Final decision to be made by the Selection Committee (which is for 2020/21: Fixtures Sec, County Team Coach, Lead Team Manager, GTM, BTM and Head Coach of 4 Top Clubs (Counties) not represented by preceding members (ie AVSC, NPSC, ADSC & WWH). This might need to be cross referenced with Level X swims up to August and communicated to clubs. Therefore, coach involvement AND racing evidence would be used to make it a little more infallible and fairer.

We did suggest potentially 40 swimmers for the Sunday. Splitting the group into 2 x 20 swimmer groups (20 boys, 20 girls) with groups of 6-7 swimmers per group coach (6 group coaches needed). We can then rotate land work and pool work with 20 swimmers on land, 20 swimmers in the pool and rotate around. Regarding parent interaction, we could put together pre-recorded videos for the parents or do an online zoom/teams meeting for them. We will then be looking at quite a number of inclusions for the swimmers and keeping people in the water. Plus more involvement for coach development.

I'm signing myself and some key coaches up to a full a weekend but I think it will be worth it. And dependent on the facilities you choose to use we could easily fit that number in the pool.

In a nutshell: Saturday as normal with previously invited swimmers; Sunday slightly different with more swimmers.
