Chair's Report March 2023

Massive thanks go to all those who worked so hard to ensure the 2023 ONB Championships were so successful and special thanks to Sharon McNab who stepped into the role this year. As always these championships would not be possible without the many hours of help from ALL volunteers, both poolside and behind the scenes; your time and efforts are much appreciated.

Congratulations to each and every swimmer who competed we hope you enjoyed the experience and congratulations to our winning club, Maxwell, who were the top club for the first time in 10 years.

Four members of ONB (myself as Chair, Nicky Mellings as Secretary, Oliver Stockland as President and Lucie Clarke as County Welfare) attended a County Governance Day with Swim England on 11th March to discuss a new County Governance Code and The Role of Counties. This is following a survey that Swim England sent to all County Associations throughout England. A copy of the presentation and materials are attached to this report for information.

Briefly the day covered:

- A new Code of Governance for County Associations is to be introduced in 2023 (Matrix III) and 75% of all associations are expected to be compliant by the end of 2023.
- We will need to provide information on Governance, Welfare, Equality & Diversity, Health & Safety, and Workforce
- There were discussions about the challenges we face at a County level.

- Discussions about Welfare and Safeguarding and whether a County Welfare Officer is needed. Lucie was praised for her level of engagement and knowledge and is already implementing many of the actions Swim England is planning
- Suggestions were made about splitting Artistic, Water Polo and Diving out of County remit and these would be covered just at a Regional level
- Slight concern was raised regarding the fact our County Coaches are not contracted.

Overall I felt that ONB is considered to be in a good condition but all County Associations will have a further meeting with a Swim England representative where actions specific to ONB will be addressed.

Banking

We are still having ongoing issues with Barclays which is not currently affecting our ability to pay bills. As I am not present at this meeting, the Chair will explain the issues we have faced since last August with Barclays Business Banking.

At this meeting, I would like the ONB Executive to agree the following:

- To amalgamate the current General and Competitions Accounts into one.
 Separate accounting (competitions, general and reserve) will still take place and be reported at each Executive meeting. Currently the Competitions Account gains no interest despite significant money being in it.
- To move all accounts away from Barclays Bank.
- To open accounts with Metro Bank. The agreement of the Executive is required in accordance with our constitution. Metro Bank:
 - o operate community accounts.
 - o have branches open 7 days a week in Aylesbury and Oxford.
 - o accept cash payments which we need for the Counties.
 - have online banking.
- To open a Metro Bank "Community and Charity Bank Account". As we have less than 200 transactions per month, this would be a no charge account. This account would operate with a running balance of £1000.
 Community current account
- To open a Metro Bank "Community Fixed term Deposit Account" for one year which has a fixed interest rate of 3.01% AER. To deposit £17,000 into this "Community Fixed term Deposit Account".
 Community Fixed Term Deposit Account
- To open a Metro Bank "Community Instant Access Deposit Account" which currently has an interest rate of 0.6% AER. This account will be used to hold the remainder of the ONB money with easy transfer to the main current account as and when required.
 - Community instant access deposit account

- To confirm in the minutes of this meeting that the key official roles (Principal Officers as stated in the constitution are:
 - o Chair
 - Secretary
 - o Treasurer
- To confirm in the minutes of this meeting that the people appointed to the key official roles are:

 - O Secretary Nicola Mellings
 - o Treasurer Christine McLintock
- To confirm in the minutes of this meeting that the people authorised to operate the accounts are:
 - O Christine McLintock, Karen Underwood and Sharon MacNab
- To confirm in the minutes of this meeting that the account signing rule will be two of the three authorised people.

Thank you to all the Officials' who volunteered to help at this year's Championships and thanks also to Felicity Govan for her assistance in organising the volunteers.

We had 77 Officials covering 173 roles over the long distance and 400s weekend and 81 Officials covering 390 roles over the main weekends. Many Officials were able to gain valuable mentored experience in trainee roles and some were able to qualify a new Officials or obtain a new qualification, congratulations to all.

We are currently running a survey to ascertain whether our ONB Officials wish to change the uniform worn by technical officials at its licensed meets to black instead of white. We will still retain white polo shirts.

If this change is implemented, it is expected that ALL clubs within the County adopt this change so that there is consistency throughout (allowing for a transition period) and this change will be fully implemented at next year's County Championships.

The new World Aquatics (FINA) rules were implemented as of 10th March and SE Region has just started a course of zoom meetings for referees to update them of the changes. It is planned that ONB will run a series of CPDs on rules changes via zoom meetings for all officials within the County. It is my understanding that ALL licensed Officials will have to attend one of these CPDs before 31st August 2023 to retain their licence.

I am still waiting to receive the training material so that we can start these sessions, as soon as this is received link will be sent to enable people to sign up to a suitable date.

ONB County Coord Sec – Report for March ONB Meeting

- 1. Intercounties The team intend to travel to Sheffield the night prior to inter counties and stay over. We have not researched accommodation yet but wanted to see provisional approval for this from the committee. We have no idea on cost or arrangements as we will finalise this if we get provisional approval.
- 2. Counties The vast majority of clubs supported the volunteer process at counties. We managed to fill almost all the roles with clubs like Banbury, Bicester, CMK, Maxwell and Kidlington stepping in to cover roles certain clubs would not fill. Other clubs also helped fill the roles but these clubs came forward the most when the cry for help went out. It should be raised that we cannot run these championships without volunteers; Aylesbury District failed to fill over 30% of their roles. Allocation was based on number of swimmers per gala and they filled 19/32 They were by far the worst offenders and made organising the volunteers particular difficult.
- 3. We are targeting 6th April and 3rd September for this years' Development Camps. We are awaiting confirmation from Stantonbury in regards the pool booking and costs. Currently we have only 20 swimmers identified (12 girls and 8 boys). Only 4 out of 16 clubs have both boys and girl representation.

County Welfare Officer Report March 2023

<u>Hot topic – period wear!</u>

Having been in place for a few months now and opened those communication channels with the Club Welfare Officers, there is a common theme being discussed with me and that is of the Swim England guidance on period wear at events, whether licenced or unlicenced. This is understandably a sensitive topic for most clubs as many of their members are girls around the age where this is likely to affect them, at a time where they are just getting their head around changes to their own body. Having spoken to a few WO, I believe that most of the concerns are likely to be around how this has been communicated and how the guidance reads – I have fed this back to Swim England, although have not had any response.

In the interim, Karen has kindly clarified that as long as someone, whether that be the swimmer, a parent, a friend, the coach (or any other person) informs an official prior to the event that they are wearing period wear, then this will suffice. It is not mandatory for the Coach to be made aware, or any other member of the club. My understanding is that some clubs within our County are insisting that the coach needs to be made aware so they can pre-empt any DQ and deal accordingly. The guidance makes it clear that "swimmer's privacy will be respected by all individuals". As such, there is no need for a coach to be aware if that swimmer is not comfortable with this – as long as an official knows.

Having been present at the ONB Counties, I witnessed this process and the list where the information is stored. It is all very discreet. I had promised to send out an email to all WO to confirm this process and was planning to do so this week, when I have been made aware of another event a club took part in where the officials present there said they would not be seeking information on anyone wearing period wear as it did not benefit anyone involved. I have asked for further clarification on this before sending out any communication as I want clear understanding of when this information is required at a meet, and if it doesn't apply to all, then how do clubs/swimmers know if they need to or not (to avoid swimmers informing people of this personal information unnecessarily).

Counties 2023

I was present at as many of the events as I could, and this being my first term as CWO, it has given me much to reflect on and to put in place prior to next year's competition. Sharon did a fantastic job and there was clearly a lot of work on her. Unfortunately, I couldn't make it to the first two weekends, and I wrongly assumed there would be WO there from each club. When I became aware this was not the case, I contacted all WO to see who was planning to attend the events moving forward and was then able to provide Sharon with a "rota" of all WO that would be on site throughout the whole of the Counties moving forward. I will ensure this is done in advance for next year. Although not in attendance at all sessions, I was and will always be on the end of the phone in case of any concerns.

Having said this, I am not aware of any welfare issues. There were a couple of issues brought to my attention such as swimmers being in dry changing areas unsupervised but this was easily addressed.

It was a great opportunity for me to meet several of the WO and club team members to make them aware of my role and ability to contact me if needed.

Club Welfare Officers

I have now made contact with most WO within our affiliated clubs. I asked all WO to get back to me confirming that I have the correct details for their club, and also just to make sure the email worked! There are a couple of clubs I have yet to hear from: **Buckingham, City of Oxford Water Polo, In Synch, & Wantage White Horses.**

Interestingly, the role of County Welfare Officer was discussed in the recent County Roadshow and it seems that some may not perhaps be as involved as I might be, and therefore might not be making contact with all their club WO as above. However, my thoughts are that if I have the County role I want to make sure I have some responsibility for ensuring our clubs within our County at least have the WO in place and they are able to be contacted. I will feed back to the relevant Chair's for the Clubs I have not heard back from.

There are a few other minor admin bits I would like to feedback on such as some WO using their personal email addresses, and will look to do this in the near future.

The region sent a team of 26 athletes to compete in the Luxembourg Euro Meet in January. This was led by Head Coach Paul Lloyd. The standard of competition was extremely high with several international starts such as Chad Le Clos and Ben proud. ONB were represented by Harry Wynne – Jones and Ruby Stephenson from CMK. Both coming away with Junior medals.

SwimMark and Club Affiliation

Congratulations to Bicester Blue Fins, Bletchley and District, CMK, Newport Pagnell and Witney and District SC for maintaining their SwimMark this quarter. The following clubs have successfully completed club affiliation this quarter; City of Oxford Water Polo, Henley SC, Insynch Milton Keynes, Oxford Brookes University, Oxford University WP, Sunflower SC and Wantage Youth SC.

We are asking all SwimMark clubs to update their constitutions in line with the 2022 model in time for their reaccreditation this year. We will be asking the non SwimMark clubs to do this in time for their club affiliation deadline early next year. Thank you to Chris Hobbs from Sussex who has been checking the ONB constitutions so efficiently on behalf of the region.

Swim England Health Check for Clubs

A few months ago, Swim England launched a club health check tracker. The tracker, delivered by Sporting Insights, is an online platform that will be used to support aquatic clubs with continuous improvements within six core areas of club development.

The six areas of coaching and teaching, financial management, pool operator relationships, governance and standards, growth, and volunteers will all be assessed as part of a self-assessment survey which clubs can complete in the tracker once a year.

Clubs have been sent their user details. After completing the survey, clubs will be shown an interactive results section which displays their scores compared to an average from other clubs up and down the country.

The aim is to help clubs identify their areas of strengths and weaknesses so they can target their development. The tracker also provides support to make those improvements with results catering to each individual club's needs.

Each discipline section of clubs will be invited to complete the tracker, this ensures all sections of clubs will be supported and discipline-specific benchmarking of results is possible.

Clubs have been sent their login details already but if you have not received them please contact clubdevelopement@swimming.org the deadline for clubs to complete this is the 22nd March.

Swim England Handbook and Wavepower

The Swim England Handbook has recently been updated and released and includes a number of regulation updates in relation to the Club Complaints procedure, Judicial complaints and Safeguarding and Welfare.
