

FUNDING APPLICATION FORM

Oxfordshire & North Buckinghamshire County ASA (ONB ASA) may provide funds which can be applied for under the categories below. Applications should be submitted in a timely manner to enable proper consideration (approval/rejection) at the ONB ASA Executive Committee Meetings.

Completed application forms need to be e-mailed to the ONB Treasurer on ONBTreasurer@gmail.com

Any agreed funds must be spent within 1 year of the date of agreement otherwise a new funding application will have to be submitted.

ONB ASA funding falls into the following categories, but is not limited to:

- Training/Coach Development (Levels 1, 2 and 3 coaching courses).
- Equipment (Technique aids, the purchase/repair/replacement of pool equipment).
- Athlete Development.

Funding is not available for:

- Competitions.
- Overseas training camps.
- Laptops, iPads or similar devices.
- Swim teaching courses.

Reimbursement will only be made once proof of purchase or the coaching certificate has been submitted to the ONB Treasurer.

For coaching development course funding, the applicant must have been:

- volunteering with their club for at least 6 months prior to the date of the funding application for a Level 1 course.
- coaching at the Club for at least 6 months post Level 1 for a Level 2 funding application.
- coaching at the Club for at least 12 months post Level 2 for a Level 3 funding application.

Maximum funding requests for Coach Development are listed below, the remainder can be obtained from the SouthEast Region Coach Bursary <u>Grants and bursaries - ASA South East</u> Region website (southeastswimming.org)

- Swim England Assistant Coach (Previously Level 1) courses: ONB will fund 50% of the course cost.
- Swim England Coach (Previously Level 2) courses: ONB will fund 33% of the course cost.
- Swim England Senior Coach (Previously Level 3) courses: ONB will fund 25% of the course cost.
