RULES AND CONDITIONS

GENERAL CONDITIONS

- 1. Lead Referee: Karin Vazirani, Promoter: Dave Heathcock, Meet Manager: Leah Pullen
- 2. This gala will take place at Northolt Leisure Centre, Eastcote Lane North, Northolt, Middx UB5 4AB and is licensed by the Swim England at Level 3 under License number 3LR24
- 3. It will run short course (25m) in accordance with Swim England Laws and Swim England Technical Rules of Swimming and the rules and conditions of this competition.
- **4.** The Meet will be open to Ealing SC and up to seven clubs invited by the promoter.
- **5.** Over the top starts may be used at the promoter's discretion.
- **6.** The pool is 25m long, 8 lanes, anti-wave lane ropes and electronic timing. The depth of the shallow end is 0.9m and the deep end is 2.0m.
- 7. No outdoors shoes to be worn on the poolside. Footwear must be worn outside the pool area.
- 8. SPECTATORS Entry will be £10.00 for the day. A copy of the result sheets will be provided to clubs at the end of the gala if possible or will be available from our website as soon as possible after the gala.
- **9.** The pool will be cleared 10 minutes before the start of the session.
- 10. All events are Heat Declared Winner. Awards will be given to the top three swimmers in each age group (9/10, 11, 12, 13, 14, 15+). Any medals not collected on the day will be forfeited.
- The Pool will be available for warm-up before the start of each session; see the summary programme for warm up timings. A second pool is available which will be available for continuous warm up and swim down during the meet.
- **12.** There will be a secondary strobe available.
- 13. ESC reminds all those attending that the meet is under the pool operator's photographic policy. Anyone wishing to use a camera, mobile phone camera, or video camera, is reminded to adhere to the Swim England guidelines on the use of images and restrict to their own child and their own private use with no posting on social media or similar platforms. You are reminded that Flash photography is NOT permitted at the start of any heat. Photography or taking of any media is not permitted in the changing room.
- 14. This Meet has been licensed at Level 3 by Swim England. Times recorded at the meet will be accepted for entry into County Competitions, and will be sent to Swim England for inclusion in the National Rankings.
- 15. Coaches' / Team Manager passes are £10 per day or £20 for a two-day pass per person to a maximum of 5 per team. (This will entitle the holder to admission and programme, session start lists, teas/coffee at the start of each day and poolside refreshments.) or £25per person, per day to include lunch as well.
 - Passes/Wristbands must be displayed at all times, entry to poolside will not be permitted without a pass. You are reminded that under Swim England new guidelines satisfactory ratios of coaches/TM to athletes should be applied.
- **16.** Where possible there will be a photographic shop and a swim shop.
- 17. To ensure the Meet can run effectively and efficiently, we encourage all clubs to help where possible with officials. Trainee officials are also welcome and we will endeavour to provide mentoring, if numbers permit.
- **18.** Officials may claim Travel expenses. Please read <u>ESC Meet Expense Policy</u>. Claim form may be found on <u>ESC website</u>.

ELIGIBILITY FOR ENTRY

- **19.** Events: 50m 100m 200m all strokes, plus 100m, 200m and 400lM and 400m Freestyle.
- **20.** Entry fees are £9.00 p/event.
- **21.** Age bands are 9/10, 11, 12, 13, 14, 15+. Ages as at midnight 3rd March 2024
- The Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category, a swimmer confirms that their birth sex is female.
- 23. Swimmers must be Swim England registered at Club Compete (category 2) and have a Swim England registration number.
- 24. Additional entries may be accepted after the entry closing date if space is available at the discretion of the Meet Promoter. Only swimmers already entered into the meet may apply. Time Trials (TT) will be offered where there would otherwise be empty lanes. Competitors wishing to swim time trials on the day should go to the Time Trial / Computer Helpdesk upon arrival at the start of each session prior to warm up. There will be a charge of £10.00 per time trial swim. There will be no awards for

- **25.** A time standard table is attached. Swimmers entering this Meet are expected to enter their current best times and must **NOT** enter faster than the time limit shown.
- **26.** Swimmers with classifications (S Categories) and those who require additional provisions to access the event are requested to notify the Meet Promoter in advance of the meet. They will be accepted at the Promoter's discretion.
- 27. The closing date is 10PM 15th February 2024. Times cannot be amended after the closing date.
- 28. For Team entries please complete the online Summary/coach pass form (summary form link here)
 https://ealingsc.wufoo.com/forms/zrnsu890maykx8/ this will also allow you to submit the Hy-Tek entry file electronically.
 Entries will not be accepted without the Summary Form.

- 29. Entry fees should reach the Promoter no later than 10PM 15th February 2024.

Please note that if a Club enters more than 6 swimmers by means of entry forms rather than Hy-Tek Manager Event File, these entries will incur an administration fee of £18.00 p/entry.
- 30. We will process personal data submitted by the swimmer or their club in accordance with the current Privacy Notice published by British Swimming. With respect to this meet we will process personal data for the legitimate purpose ofrunning the gala. The items of personal data processed are name, Swim England registration number, date of birth, gender and paraswimming classification if applicable. During the gala we will process name, gender and competition age in reports for the legitimate purpose of running the gala efficiently. At the end of the gala we will process name, gender, Swim England registration number and date of birth in the electronic submission made to British Rankings. We will also make this information available on request to the club of the swimmer as the data controller.
- 31. By submitting and accepting entries to the meet, consent is hereby given, as required by the Data Protection Act 1998,to the holding of personal information. The personal information supplied with your entry will be retained securely and will only be used for the legitimate purposes of running the event. This data will be shared by form of results with Swim England (Rankings) and the clubs who have entered the meet. A full copy of the results will be published on the website after the meet. Please be aware that links from our website may take you to external websites that are not covered by our policies. Please ensure that you review their privacy policies before any data is submitted. If any persons want to exercise their right to erasure or processing of their personal data, they will need to make a written request to the promoter. We will only hold competition data for 12 months after which it will be destroyed and erased from our system.
- This meet will operate as a **CARDLESS** meet. Entries will be pre-seeded before the meet. Any withdrawals must bemade 45 minutes before the start of each session at the withdrawal desk.
- 33. Should the meet be oversubscribed, every effort will be made to minimise the number of rejections, whilst ensuring the meet remains balanced across all events/age-groups and fits within the available swim time. This is likely to be done by admitting the fastest swimmers first until the heats are full. The Promoter reserves the right to adapt or change this method if necessary. Refunds will be made for rejected entries only. The promoter's decision in this matter is final. There will be no refunds for withdrawals after the closing date other than withdrawals for medical reasons that must be accompanied by the appropriate certification.
- 34. All participants must observe the safety precautions in operation at Northolt Leisure Centre. Neither the Meet Management, the Promoter nor Ealing Swimming Club will be responsible for any loss or damage occurring during this meet. Clubs are reminded of their duty of care to their swimmers during a meet and that they should have with them full contact details of parents/guardians for all swimmers attending the meet. They should also hold any details on medical conditions that may be deemed necessary.

COVID

Participants are reminded that they should not attend if they have a high temperature, cold like symptoms, a new, continuous cough, and a loss of, or change to, their sense of smell or taste.

Any matters concerning the Meet not covered in these rules will be dealt with according to the laws of the Sport and at the discretion of the Meet Management or the Promoters.
